Motion by Price, seconded by Smoke, to accept the bills submitted for September, 2020 payment, General Fund - checks numbered 22906 through 22964, Fire Assessment - checks numbered 13491 through 13500, Garbage Assessment - check number 9102. Roll call vote: Margrif, yes; Martin, yes; Sorge, yes; Price, yes; Smoke, yes. All yes, motion carried.

Bob Breckenridge, Forest Township Zoning Administrator, discussed with the Board various items that he has addressed through the last month.

Motion by Smoke, seconded by Sorge, to adopt a resolution to allow the Supervisor to contact Davison Land and Survey to have the cremation section mapped out with lot numbers if its \$500.00 or less. Motion by Margrif, seconded by Price, to adopt a resolution to accept the new cemetery pricing for resident at time of need \$25.00 each up to 2 graves, resident not at time of need \$350.00 per a grave and non-resident \$500.00 per a grave with the deletion of escrow and years of residency. Roll call vote: Sorge, yes; Martin, yes; Price, yes; Margrif, yes; Smoke, yes. All yes, motion carried.

Supervisor Price closed regular meeting at 6:30p.m. and Opened Special Assessment meeting at 6:30p.m. The Township Board took comments from the public.

Motion by Price, seconded by Martin, to adopt a resolution to rezone 9491 Vienna Road to RU1. Roll call vote: Smoke, yes; Martin, yes; Smoke, yes; Price, yes; Margrif, yes; Sorge, no. Four yes, motion carried.

Motion by Smoke, seconded by Price, to close the offices November 9 & 10 for BS&A training. Roll call vote: Price, yes; Smoke, yes; Sorge, yes; Martin, yes; Margrif, yes. All yes, motion carried.
